4. The Quotation should clearly mention the rate in bulk amount for filing of quarterly/ annual returns, Form-16 returns as well as returns in correction mode etc.

5. The rate quoted for the work should be inclusive of all taxes.

6. The tenderers or their authorized representatives may present at the time of opening of tender.
