- 7. The period of contractual engagement shall not be counted as Government service for the purpose of pension and any other retirement benefit.
- 8. The engaged retired Peons/Group-D Employees will be subject to and will abide by the Conduct Rules applicable to the Government Servants.
- 9. The contractual engagement may be terminated at any time by the Member, Board of Revenue for unsatisfactory performance, on notice of one month, and in case of any misconduct including, but not limited to, misappropriation, negligence or causing loss to Government, without any prior notice.
