II. The Online Examination portal will remain open from 20<sup>th</sup> October 2023 to 20<sup>th</sup> November 2023. Candidates are required to apply online for appearing in the examination by visiting the Board of Revenue's website (**boardodisha.nic.in**). Before filling up the online application form, they are required to go through the instruction available in the Board's website. The detailed Programme Notification has been enclosed. (Annexure-I)

III. No offline application or partially filled online application without recommendation of higher authority shall be accepted.

IV. The names of the Examination Centres chosen by the Districts must be intimated to the undersigned by 15.11.2023. In the Examination Centre, adequate number of rooms must be used to avoid overcrowding of candidates in 2 or 3 rooms.

V. The District Administration will be given access to the Online applications for verification in the District Login link after the last date of application. A Unique ID and Password will be provided to all districts for verification of applications and Online Attendance Entry. Online verification of applications must be completed by 30.11.2023.

VI. Though it is an Examination with books, it is requested to conduct it strictly.

VII. It must be ensured that no mobile phones/ smart watches/ Guide books/other electronic gadgets shall be permitted inside the examination hall.

VIII. As per Rule, the Examination shall be held under the supervision of the Collector/ ADM, who shall be assisted by such number of other officers as may be necessary. On the examination days, a senior officer duly authorised by the Collector shall take out the sealed question packets from the treasury and take it to the examination centre.

The Hon'ble Member, Board of Revenue, Odisha has instructed to conduct the examination strictly. Hence it is requested to take all necessary steps to ensure conduct of the examination in a strict and fair way.
